- 1 Rates are EXCLUSIVE of GST.
- 2 The aforesaid rates are basic discounted rates on FOR destination basis.
- 3 The stores will be supplied within 30 days from the date of receipt of supply order from Master Canteens.
- 4 Payment will be made within 30 days from the date of receipt of stores by the Master Canteen.
- 5 Benefit of GST exemption will be given to those Master Canteens who are exempted from GST by the State Govt
- 6 In case of decrease in MRP, CPC rates will be reduced to the extent of percentage discount agreed and information will be given to CPC HQr
- 7 Special discounts/schemes if any shall be passed to the Master Canteens immediately. Master Canteens are permitted to accept special schemes without further .
- 8 MRP of the products if found lesser than that of quoted in negotiation, lesser MRP will come into immediate effects with same percentage discount agreed upon and will
- 9 In case of quality of product and its contents are found to be of inferior quality than the sample produced or what has been decided upon, the agreement/contract is liable
- 10 Firm are bound to supply their products to far- flung and remote areas where MCs are located.
- 11 Cost of unloading of products at MCs will be born by the firm concerned
- 12 If at any point of time during the contract, it is found that market rate are lesser than CPC rates than your Firm will be liable to be delisted with immediate effect.
- 13 Business Turnover should be minimum Rs.25 Lakh in one year of registration for renewal
